

MINUTES OF CIVIL SERVICE BOARD
CITY OF SACRAMENTO
SPECIAL MEETING

October 17, 1933

The Civil Service Board met in special session in the office of the Board, Room 106, City Hall at eight o'clock P.M., President Weisman presiding.

PRESENT: Commissioners Chenu, Deise, President Weisman.
ABSENT : None.
