REPORTS OF DIRECTOR OF PERSONNEL

Mrs. Donna L. Giles, Director of Personnel, addressed the Board and informed that per the Board's request, a special meeting was scheduled for November 30, 1982 at the Data Processing Department for a tour of the data processing facilities, and that a special meeting notice would be forthcoming.

HEARING ON APPEAL

Joyce Horizumi - Associate Planner Examination

Mr. Frank Hughes addressed the Board and stated that he was a representative from Stationary Engineers, Local 39, and that he had no further testimony.

Mrs. Nance indicated that she had heard the tape of the previous Civil Service Board meeting of November 2, 1982, at which this issue had been discussed, and there was some discussion on the 30-day appeal period. Mr. Lee Savage, Deputy City Attorney, addressed the Board and explained that Ms. Horizumi had appealed her disqualification, and that Mrs. Giles had denied the appeal because it was not received in a timely manner.

There was some discussion on the Police Lieutenant assessment center, and the question was raised about tape recording this portion of the examination. Mr. John Worcester, Personnel Services Manager, and Ms. Thelma Vanesian, Personnel Analyst I, explained the impracticality of trying to tape an assessment center exercise, and there was some general discussion on the taping of exams. Mr. Worcester informed the Board that only certain examinations were taped, primarily the fire and police classifications, and any others which were considered controversial.

There was some discussion on the experience requirement of two years' service as a Police Sergeant and the cut-off date of February 19, 1983.

Ms. Placencia entered the meeting at 1:53 p.m.

There was some discussion on the promotional examinations of Zoo Attendant II and Police Clerk III.
