SUBJECT: Enforcement of Section 25.150 Sacramento City Code, relating
to Parking of Vehicles on Private Property.

SUMMARY

This report concerning enforcement of Section 25.150, Sacramento City Code, the Nuisance Abatement Division, is submitted for information only and requires no action.

BACKGROUND

On March 31, 1987, the City Council by resolution number 87-224 expanded the Citation and Arrest authority of Nuisance Abatement Officers and Parking Enforcement Officers assigned to the Nuisance Abatement Division to include Section 25.150. This section was amended (Ordinance 87-025) on March 24, 1987, to deal with the problem of vehicles parking on unimproved surfaces and vehicles parked on vacant improved or unimproved property when such vehicles were offered for sale.

When the new Citation and Arrest authority was approved, Councilmembers Kastanis and Robie, requested a report back in six months to the Transportation and Community Development Committee on the enforcement of Section 25.150.

As of September 30, 1987, Nuisance Abatement Officers and Parking Enforcement Officers of the Nuisance Abatement Division, issued 574 citations to vehicles which were parked in violation of the provisions of Section 25.150. Appendix I of this report shows enforcement activity by Council District.

The overall enforcement program has been successful. However, there exists a standing backlog of violations due to the notoriety which the program has received. That subject will be addressed in a report to the joint Budget and Finance, Transportation and Community Development Committees at a later date.


FISCAL DATA

RECOMMENDATIONS


