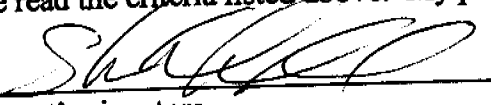

Brief Description of Project: MINOR DEV-KOT REPAIRS ON FRONT & SIDES  
(FRONT HALF OF BLDG.), TI-II & PATCH STUCCO TO MATCH EXIST.

The repair, replacement and/or maintenance of exterior siding in Design Review Districts are exempt from Design Review if they meet the following criteria:

1. The value of the work does not exceed one thousand dollars (\$1,000) in a 36 month period.
2. The portion of the exterior siding repaired or replaced does not exceed ~~50 percent~~ <sup>25%</sup> of the existing exterior siding in a 36 month period.
3. The repair or replacement of the exterior siding shall match the design and materials existing on the structure at the time of the proposed work.
4. The project will not expand the existing structure.
