

STAFF ACTION AND CONDITIONS OF APPROVAL:

Staff has reviewed the proposed project, and approves it with the following conditions of approval:

1715 V Street:

1. Replace damaged stucco siding to match existing. Siding not to exceed 1000 square feet.

1713 V Street:

1. Remove all existing siding. Provide new wood lap, smooth finish siding.
2. Provide new single-hung vinyl windows where necessary. No change to existing opening size is allowed.
3. Repair/replace damaged wood trim as necessary. Match existing.
4. Provide new stairs and railing per attached detail.
5. Paint all new woodwork and siding.

1713 1/2 V Street:

1. Replace damaged wood siding to match existing.
2. Provide new stairs and railing per attached detail.
3. Paint all new woodwork and siding.

Note: The scope of exterior work is limited to the above listed items. Any changes are subject to Design Review staff approval.
