

RESOLUTION NO. 2007-474

Adopted by the Sacramento City Council

June 26, 2007

APPROVING THE MODIFIED 2007 REGULAR MEETING SCHEDULE FOR THE CITY COUNCIL; 2) DESIGNATING FOUR WEEKS WHEN REGULAR CITY COUNCIL MEETINGS NEED NOT BE HELD; 3) RESCHEDULING SEVERAL MEETINGS TO BE HELD ON THURSDAYS; AND 4) REPEALING RESOLUTION 2006-816

BACKGROUND:

- A. The Brown Act (§54954a) requires that legislative bodies, except for advisory bodies and standing committees, provide for the time and place for regular meetings by ordinance, resolution, or by-laws.
- B. The City Charter, Section 31 allows for the City Council to hold regular meetings at such times and places as may be fixed by Resolution, except that the Council shall meet after 5:00 p.m. not less than one evening each week.
- C. The City Charter, Section 31 allows for the designation of four weeks a year wherein regular City Council meetings need not be held.
- D. The Council Rules of Procedure adopted by Resolution No. 2007-283 on May 15, 2007 modified the times associated with the previously adopted annual meeting schedule.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1. All meetings held from January to June 2007 are acknowledged as past events.
- Section 2. The weeks of July 2 through July 13, 2007 (summer recess) and December 24 through January 4, 2008 (winter recess) are designated and confirmed as the four weeks in which regular City Council meetings need not be held.
- Section 3. The afternoon (2:00 p.m.) and evening (6:00 p.m.) meetings on Tuesday, August 7 are confirmed and rescheduled to Thursday, August 9 to allow for participation in National Night Out activities.
- Section 4. The Council meeting calendar for 2007, attached as Exhibit A and incorporated herein, is approved as the City Council's calendar for regular meetings in 2007.
