**Subject:** Name change: Reassign contract for 2005-06 ArtScapes Grantee 2005-0161 from Urban Jazz Workshop/ Sacramento Area Black Caucus to Internal and International Culture and Education Exchange

**Summary:**

The ArtScapes grantee, Urban Jazz Workshop and Sacramento Area Black Caucus, a community group, has withdrawn from the ArtScapes Program. The core member of the proposal team (Sheila Riley) has renamed the group, "Internal and International Culture and Education Exchange" (I&ICEE), and plans to continue the proposed project. The core of the proposal, the continuation of the African American Masters of Music (AAMM) series, will remain the same as originally proposed. By continuing without the umbrella organization, I&ICEE is in accordance with the ArtScapes grant principles, designed to give money directly to the arts group.

**Background Information:**

The 2005-2006 ArtScapes funding was approved on Resolution 2005-785, dated November 4, 2005. The grantee, Urban Jazz Workshop and Sacramento Area Black Caucus, a community group, was approved for funding under City Agreement 2005-0161 for the amount of \$3,102. This group withdrew from producing the AAMM series after the grant was awarded. The lead applicant, Sheila Riley, would like to continue the project under the new name, I&ICEE.

This grantee's original proposal was to host the AAMM series, consisting of two concerts to be held in February and May, 2006. The music for this concert was to be played by Steve Gundhi and his jazz quartet at the Fox and Goose in downtown Sacramento. Under the arts group newly named I&ICEE, both AAMM series concerts will take place at the Capoeira Arts Academy at 1811 Del Paso Boulevard in June and August, 2006. The musicians will remain the same.

First approved by Council on August 26, 2003, the ArtScapes grant's mission is to foster projects that will be culturally significant, of rich artistic quality, and that help build the region's identity. The program seeks to fund projects in any art form or discipline that present an exciting and fresh approach for new projects, or a well-produced and dynamic approach to continuing projects, and are engaging to the projects' audiences and/or participants. The program seeks to reach out to new and emerging artists, multicultural artists, as well as established arts groups. Applicants can be new groups, non-profit organizations or businesses.

**Financial Considerations:**

The I&ICEE's total grant amount will be the same as the previous grantee, Urban Jazz Workshop and Sacramento Area Black Caucus, a community group, at \$3,102. This amount is reserved in the Arts Stabilization Carryover. No funds have been paid on the original agreement.

The disbursement period for this grant cycle was November, 2005 through December, 2006. Grant funds are generally paid in two installments, half of the award amount at the execution of the agreement, and a final payment when the project and its evaluation are completed. The grantee's name change requires no contract extension.

**Environmental Considerations:**


The Planning and Building Department, Environmental Planning Services staff, has determined that this grant program is not a "project" under the California Environmental Quality Act (CEQA) Guidelines section 15378(2) (4). The proposed grant program is not a "project" as defined under CEQA because it is a creation of a government funding mechanism that does not involve a commitment to a specific project that may have a potentially significant impact on the environment.


**Policy Considerations:**

As per SMAC's Business Plan and the City's Strategic Plan, the ArtScapes program attempts to achieve sustainability and enhance livability by providing quality arts programming to the citizens and visitors of Sacramento.

**Emerging Small Business Development (ESBD):**

ArtScapes is a grant program, not a procurement activity, and as such, is exempt from inclusion in the ESBD program; grantees are small businesses, as defined by the State of California, averaging under \$10 million annually in gross receipts.



**APPROVING A NAME CHANGE FOR 2005-06 ARTSCAPES GRANTEE**

**BACKGROUND**

- A. The 2005-2006 ArtScapes projects were approved on November 1, 2005, on Resolution 2005-785. The grantee, Urban Jazz Workshop and Sacramento Area Black Caucus, a community group, has withdrawn from participation in the ArtScapes program. The core member of the proposal team (Sheila Riley) has re-organized to continue the proposed project under the new name "Internal and International Culture and Education Exchange" (I&ICEE).
- B. The budget for this project is funded in the amount of \$3,102 from the Arts Stabilization Carryover (Fund 101, Agency 750, Org. 7116).

**BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:**

- Section 1. City Agreement 2005-0161 with Urban Jazz Workshop and Sacramento Area Black Caucus, a community group, is cancelled.
- Section 2. The City Manager is authorized to execute the agreement with Internal and International Culture and Education Exchange (I&ICEE).
