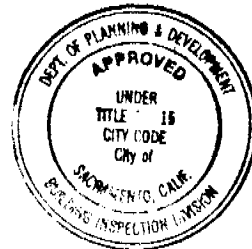
STAFF ACTION AND CONDITIONS OF APPROVAL:

Staff has reviewed the proposed project, and approves it with the following conditions of approval:

1. Remove existing trim 1x2 trim at all elevations of house.
2. Provide a new stucco finish at all four side of house. Stucco shall have a smooth finish.
3. Provide new decorative trim and sills at all window locations.
4. Paint home a field color and all trim shall be painted a contrasting accent color.
5. The scope of exterior work is limited to the above listed items. Any changes are subject to Design Review staff approval.




