SUBJECT: CITY HALL EXPANSION PROJECT (PN: BB84) - AUTHORIZE THE CITY

MANAGER TO EXECUTE SUPPLEMENTAL AGREEMENT NO. 8 WITH

TREMAINE & ASSOCIATES INC.

LOCATION AND COUNCIL DISTRICT:

City Hall, 915 I Street - Council District 1. (See Location Map – Attachment A).

RECOMMENDATION:

This report recommends that the Mayor and City Council adopt the attached resolution:

- Authorizing the City Manager to execute Supplemental Agreement No. 8 in the amount of \$229,000 with Tremaine & Associates Inc., and
- Resetting the City Manager's Supplemental Agreement authority.

SUMMARY:

This report recommends approval of Supplemental Agreement No. 8 with Tremaine & Associates Inc. (Tremaine) in the amount of \$229,000. This cost covers final compromise and settlement of all claims agreed to between the City of Sacramento and Tremaine.

City Council City Hall Expansion Project (PN: BB84) June 15, 2005

BACKGROUND INFORMATION:

In February 2003, the City entered into a Consultant Services Agreement with Tremaine for onsite archeological investigations and monitoring. Upon discovery of prehistoric artifacts, Tremaine agreed to work 10-hour days and to maintain an on-site archeology team of 25-35 persons. Six to eight Native American monitors would also be present. On September 14, 2004, City Council authorized the City Manager to execute Supplemental Agreement No. 7, in the amount of \$62,150, for additional earthwork and soil spreading activities at an off-site location. In recent discussions, Tremaine has claimed that the extensive on-site prehistoric and cultural findings resulted in expenses and costs beyond the scope of the original contract and seven supplemental agreements. This report recommends execution of Supplemental Agreement No. 8 in the amount of \$229,000 to settle all outstanding claims and disputed contract costs demanded by Tremaine. Settlement of these claims will facilitate the dedication of the Native American monument plaque and reburial of remains to be scheduled with the Native American tribe, and the arrangement for replicas of some of the artifacts to be displayed at the City Hall facility.

Completion of Archaeological Mitigation

Since the approval of Supplemental Agreement No. 7 on September 14, 2004 for Supplemental Agreement No. 7, the majority of the lab analysis and documentation work has been completed. The City's archaeologist, Tremaine, has finalized the documenting and cataloging of the artifacts discovered.

FINANCIAL CONSIDERATIONS:

As of June 8, 2005, the City Hall Expansion Project Contingency (PN: BB84) has an unobligated balance of \$964,140, which is sufficient to award Supplemental Agreement No. 8 with Tremaine & Associates Inc. in the amount of \$229,000 (Fund 711).

ENVIRONMENTAL CONSIDERATIONS:

The Environmental Impact Report (EIR) for the City Hall Expansion Project is complete. The Notice of Determination was filed with the County of Sacramento on September 21, 2001.

The actions requested herein are consistent with Sacramento City Code, Title 3, and with the City of Sacramento's Strategic Plan goal to expand economic development throughout the City.

ESBD CONSIDERATIONS:

Tremaine & Associates Inc. is an SBE firm. Construction services were procured in accordance with established City ESBD procedures. Plans and specifications for all subcontracts were sent to ESBE firms. Projected ESBE participation is 23%. Staff actively recruited available ESBE firms to participate in the bid process. The project was also announced on the Project Information Line and on the City's Internet site at www.cityofsacramento.org/bids. David Taylor Interests, Inc. is committed to meeting the City's ESBE goals through the project execution.




