- Whereas the average starting teacher's salary is \$40,000 in California and less in other States.
- Whereas the Department of Defense buys many bombs that cost \$1 million each or more.
- Whereas each \$1 million bomb costs the equivalent of **25 Teachers' Salaries**.
- Whereas the Department of Defense financial statements have not been audited since 2001.

The undersigned residents of California ask the Legislature to pass a Joint Resolution in support of America's Weapons Rebate to Education Act. 25 Teachers' Salaries has proposed this Act of Congress that will eliminate from the FY 2012 Department of Defense budget enough \$1 million (or more) bombs and missiles and other weapons to replace or rehire all the K-12 public school teachers and other educators (administrators, counselors, librarians, etc.) who have been laid off in the last 4 school years. The U.S. Treasury will give that money directly to each State earmarked for that purpose.
