SUBJECT: RESOLUTION AMENDING THE 1986-87 WATER AND SEWER  
DIVISION BUDGET FOR THE ADMINISTRATION BUILDING  
FURNISHINGS

### SUMMARY

This report is submitted to request the transfer of \$45,000 from the Water Fund Contingency Reserve to the Water Administration Budget for the Administration Building furnishings and Water Distribution work stations.

### BACKGROUND

The Council approved this expenditure in the 1985-86 budget. This money was not encumbered in the 1985-86 fiscal year because of the late award of bid on the new buildings and incomplete offices of the Corporation Yard. The funds were returned to the Water Fund balance at the close of the 1985-86 fiscal year.

### FINANCIAL

There is no increase in this request. The estimated cost of the requested equipment is \$45,000. Sufficient funds are available in the Water Fund Contingency Reserve to be transferred to the operating budget to cover this expenditure.


### RECOMMENDATION

approving the transfer of \$45,000 from the Water Fund Contingency to the City Council with a recommendation for approval.




