SUBJECT: Sacramento Job Corp Swimming Pool Agreement

### SUMMARY

This report recommends the approval of an agreement between the City and the Sacramento Job Corp Center for the operation of the Job Corp swimming pool. The agreement allows the City to operate the facility for recreational purposes to benefit the public residing in the vicinity of the Job Corp Center. The term of the agreement is June 8 through September 4, 1981.

### BACKGROUND INFORMATION

The City contracted to conduct a recreational swimming program at the Sacramento Job Corp Center during the summers of 1979 and 1980. The joint action taken by the City and the Sacramento Job Corp Center benefited local residents and Job Corp participants.

### FINANCIAL DATA

The City incurred a cost of approximately \$4,120 for the three months of operation during the FY 80-81. The cost for operation during a three month period for FY 81-82 is not expected to exceed \$5,095.

### RECOMMENDATION

It is recommended that the City Council by resolution authorize the City Manager to execute the agreement to provide a recreational swimming program at the Sacramento Job Corp Center pool.
