

# Resolution of Intention No. # 2623

Pursuant to a law of the State of California, known as Division 7 of the Streets and Highways Code; the Improvement Act of 1911."

It is hereby resolved that it is the intention of the City Council of the City of Sacramento to order the following street work to be done, to-wit:

The improvement of the following in the City of Sacramento:

C Street, Elvas Court, Elvas Avenue, Meister Way, 35th Way, 36th Way, 37th Way, and the Alley in the block between C Street, 35th Way, Meister Way and Elvas Avenue all in the Plat of Meister Terrace Unit No. 2 (as the same is shown on the official plat thereof filed in the office of the Sacramento County Recorder), by removing and disposing of all refuse and surplus materials; grading and constructing concrete curbs, gutters, and sidewalks; installing street monuments; constructing manholes complete with cast-iron curbs and covers; installing cast-iron gutter drains and connecting same to sewer system with vitrified ironstone sewer pipe; installing vitrified ironstone pipe sewer; installing Oregon Pine Header Boards where shown on plan; reconstructing existing manhole by placing curb and cover to proper grade; installing one water system complete; grading and constructing an asphaltic concrete pavement 5½ inches in thickness.

Improving Right-of-Ways owned by the City of Sacramento along the line common to Lots 27, 28, 30 and 31, Lots 28 and 29, Lots 15 and 16, Lots 36, 37, and 38; along the lines common to Lots 10 and 11, Lots 62 and 63, Lots 61, 62, 63, 64, 65 and 60, Lots 56 and 57, Lots 70 and 71, Lots 50, 51 and 52, Lots 50 and 77, Lots 76, 77 and 78, Lots 52 to 60 inclusive, and Lots 65 to 75 inclusive; and along the line common to Lots 80 to 95 inclusive, and Lots 100 to 117 inclusive; Lots 107 and 108, ~~Lots~~ 95, 96, 97, 98, 99 and 100, Lots 97 and 98, Lots 7 and 6; along the rear of Lots 118 to 135 inclusive and the line common to Lots 136 and 138, and Lots 127 and 128, all as shown on the said Plat of Meister Terrace Unit No. 2, and the line common to Lot 138 of said Meister Terrace Unit No. 2, ~~and Lot 124 of Plat of Meister Terrace Unit No. 2, and Lot 124 of Plat of Meister Terrace Unit No. 2,~~ and Lot 124 of Plat of Meister Terrace Unit No. 3 (as the same is shown on the official plat thereof filed in

the office of the Sacramento County Recorder) by removing and disposing of all refuse and surplus materials; constructing man-holes complete with cast-iron curbs and covers; installing vitrified ironstone sewer pipe; installing ~~one~~ water system complete.

All of said work to be done in accordance with the "Standard Specifications for the Improvement of Streets and Alleys and for the Construction of Sewers" heretofore adopted by the City Council and also in accordance with detailed plans made therefore by the City Engineer and on file in his office having been approved by the City Council on July 11th, 1947.

Cast-iron gutter drains shall be as shown in Cut #11 of said Specifications.

Concrete curbs and gutters shall conform to Cut #6 and Cut #13 of said Specifications.

Sewer Joints shall be made with G-K Sewer Joint Compound as Specified in Section 13 of said Specifications.

Manhole covers shall conform to Cut 1B of said Specifications.

Water Mains shall be in accordance with Standard Specifications for the installation of Water Mains, Fittings, Valves, Fire Hydrants, and Appurtenances of the Water Department of the City of Sacramento heretofore adopted by the City Council of the City of Sacramento.

Asphaltic concrete pavement shall be constructed as provided in Section 29 of said Specifications.

WHEREAS, said City Council has found and determined that pursuant to section 2804 of Division 4 of the Streets and Highways Code, of the State of California, the Owners of More than 85% of the area of the property subject to assessment for the above described improvement, have signed and filed with the City Clerk, a written petition, and said Owners did in said petition WAIVE the proceedings required by the "Special Assessment Investigation, Limitation, and Majority Protest Act of 1931", and the said City Council does

hereby approve of said WAIVER and resolves to commence proceedings as provided in Section 7 of the Streets and Highways Code, "The Improvement Act of 1911."

And whereas, in the opinion of said City Council said work is of more than local and ordinary public benefit, said Council hereby orders that the costs and expenses of said work and improvement shall be chargeable and charged upon a district of lands, which district is hereby declared to be the district benefited by said work and improvement and which is to be assessed to pay the costs and expenses thereof.

The exterior boundaries of said district and the extent of the territory included therein are shown upon the map of said district adopted and approved by the City Council on July 11th, 1947, which map is now on file in the office of the City Engineer and to which reference is hereby made for a particular description of the boundaries of said district and of the extent of the territory included therein;

Saving and excepting from the above bounden and described district the area of all public streets, alleys, ways, boulevards, courts and avenues included therein.

Notice is hereby given that serial bonds to represent unpaid assessments and bear interest at the rate of four (4%) per cent per annum will be issued hereunder in the manner provided by the "Improvement Bond Act of 1915," the last installment of which bonds shall mature fourteen (14) years from the second day of July next succeeding ten (10) months from their date.

All persons objecting to said work, or to the extent of said assessment district, are required to file their objections in writing in the office of the City Clerk of the City of Sacramento, as required by law, and notice is hereby given to all persons interested that on the 1st day of August, 1947, at eight o'clock p. m., in the Council Chamber of the City Council of the City of Sacramento, in the City Hall, on "I" Street, between 9th and 10th Streets, in said City, any and all persons having any objections to the proposed work and improvement may appear before said City Council and show cause why the proposed work and improvement shall not be carried out in accordance with this Resolution.

And the City Clerk is hereby directed to publish this Resolution twice in the Sacramento Union, a daily newspaper, as required by law.
