

MINUTES OF CIVIL SERVICE BOARD
CITY OF SACRAMENTO
SPECIAL MEETING DECEMBER 9, 1975

The special meeting of the Civil Service Board was called to order by President Wilfred Street at 1:36 p.m. in the Personnel Department Conference Room, 801 Ninth Street.

EXAMINATIONS ANNOUNCED

#1437 Fire Prevention Inspector I (Promotional)
#1442 Parking Meter Coin Collector (Promotional)

It was moved by Mr. Yee, seconded by Ms. Kuchman, and carried by unanimous vote that announcement #1437, Fire Prevention Inspector I (Promotional), be approved.

Discussion was held concerning the inclusion of other classifications, in addition to the three listed on #1442, Parking Meter Coin Collector (Promotional), which would be eligible for this examination. This matter was deferred to the next regular meeting, and the Personnel Selection staff was requested to review other classifications that could be included as being eligible for this promotional examination.

HEARING TO APPEAL TERMINATION

Wayne L. Smith, Maintenance Man I

Wayne L. Smith, Maintenance Man I, received a suspension letter dated August 22, 1975, and a termination letter dated August 27, 1975. The suspension letter was for leaving tools unattended, failing to report to work at the proper time and actions contrary to the work schedule. The termination letter was for disobeying orders and making threats to his foreman's life. Mr. Smith stated his tools were being watched by the employees of the dog pound, where he had left them, and that his threats were out of anger only. He also stated he thought other duties were more important than what his foreman had told him to do.

By letter dated September 2, 1975, to the Civil Service Board, Wayne L. Smith appealed the letter of suspension and his termination.

Deputy City Attorney Leland Savage represented the City; Attorney Charles Bitterling represented Wayne L. Smith.

Testimonies were heard from Jose Urioste, Maintenance Man II; Joe Sertich, Park Foreman I; Darryl Martineau, Park Foreman III; and Gene Robinson, Park Superintendent, on behalf of the City of Sacramento Recreation and Parks Department. Testimonies were heard from Frank Smith, Maintenance Man I, and Joe McGhee, Sr., Maintenance Man III, on behalf of the appellant, Wayne L. Smith.




Closing statements were made by Deputy City Attorney Leliand Savage and Attorney Charles Bitterling.
