

ORDINANCE NO. 1465, FOURTH SERIES.

AN ORDINANCE AMENDING SUBDIVISION (c) OF SECTION 22a OF ORDINANCE NO. 304, FOURTH SERIES, PASSED FEBRUARY 25, 1926, AND ENTITLED: "AN ORDINANCE REGULATING TRAVEL, TRAFFIC, AND PARKING UPON THE STREETS AND OTHER PUBLIC PLACES LAID OUT FOR THE USE OF VEHICLES AND PEDESTRIANS IN THE CITY OF SACRAMENTO; DEFINING THE TERMS USED IN THIS ORDINANCE, CREATING CERTAIN TRAFFIC DISTRICTS IN THE CITY OF SACRAMENTO; FIXING A PENALTY FOR THE VIOLATION OF THIS ORDINANCE, AND REPEALING ORDINANCE NO. 80, FOURTH SERIES, PASSED JUNE 22ND, 1922; AND ALL ORDINANCES AMENDATORY THEREOF," AS AMENDED BY ORDINANCE NO. 1422, FOURTH SERIES, PASSED JANUARY 14, 1949.

BE IT ENACTED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

SECTION 1: Subdivision (c) of Section 22a of Ordinance No. 304, Fourth Series, passed February 25, 1926, as amended by Ordinance No. 1422, Fourth Series, passed January 14, 1949, is hereby amended to read as follows:

(c) The following streets and parts of streets are hereby declared to be truck traffic routes for the movement of vehicles exceeding a maximum gross weight of three tons, to-wit:

14th Avenue between Stockton Boulevard and 65th Street;
65th Street between 14th Avenue and Eastern Avenue;
Eastern Avenue between 65th Street and Jay Street;
Jay Street between Eastern Avenue and 57th Street;
57th Street between Jay Street and "H" Street;
"H" Street between 57th Street and the easterly City Limit;
16th Street between the northerly City Limit and ~~"H" Street~~ **BROADWAY**;
"C" Street between 15th Street and Alhambra Boulevard;
15th Street between "C" Street and "E" Street;
Alhambra Boulevard between "C" Street and Broadway;
Stockton Boulevard between Alhambra Boulevard and the southerly City Limit;
Broadway between Stockton Boulevard and Third Street;
Third Street between Broadway and the Eye Street Bridge approach;
Eye Street Bridge Approach between Jibboom Street and Eye Street;
Jibboom Street between the Eye Street Bridge Approach and the northerly City Limit;
Capitol Avenue between Third Street and the westerly City Limit;
Eye Street between Third Street and Seventh Street;
Seventh Street between Eye Street and "E" Street;
"E" Street between Seventh Street and 17th Street;
Twelfth Street between "E" Street and the northerly City Limit;

Folsom Boulevard between 32nd Street and the East City Limit;
"N" Street between Folsom Boulevard and Alhambra Boulevard;
"P" Street between Alhambra Boulevard and Third Street;
Sacramento Boulevard between Broadway and the southerly City Limit;
Eye Street Bridge between Jibboom Street and West City Limit;
Franklin Boulevard between Broadway and the south City Limit;
Twenty-first Street between Broadway and Freeport Boulevard at Fourth Avenue;
Freeport Boulevard between Fourth Avenue and the southerly City Limit;
Riverside Boulevard between Broadway and the south City Limit;
Sutterville Road between Riverside Boulevard and Freeport Boulevard;
Sutterville Road between Freeport Boulevard and Franklin Boulevard;
Twelfth Avenue between Franklin Boulevard and Stockton Boulevard;
34th Street between Stockton Boulevard and Folsom Boulevard;
~~Eighth Street between "D" Street and "E" Street;~~
~~17th Street between "C" Street and "E" Street;~~
~~15th Street between "C" and "D" Streets.~~
