SUBJECT: Resolution Authorizing Appropriation of \$310,000 From
the General Fund to the Sacramento Northern Railroad
Bikeway Project

SUMMARY:

Attached is a resolution authorizing the appropriation of \$310,000 from
the General Fund to the Sacramento Northern Railroad Bikeway project.
Approval of the resolution is recommended.

FINANCIAL:

On May 14, 1980 the City Council received a status report from the City
Engineer on the Sacramento Northern Railroad Bikeway project. In this
report it was pointed out that \$146,000 of County Bikeway funds had
been approved by the County but had not been appropriated to the City's
Capital Improvement Budget, due to an oversight, and that an additional
\$164,000 would be appropriated after the County's 1980/81 Budget was
approved. The County's budget has been approved. Therefore, it is
now necessary to amend the City's Capital Improvement Budget by appro-
priating \$310,000 from the General Fund to this project. The General
Fund will be completely reimbursed by County funds as they are billed
for their share of the work.

RECOMMENDATION:

It is recommended that \$310,000 be appropriated from the General Fund
to the Sacramento Northern Railroad Bikeway project, by passage of the
attached resolution.
