

SUBJECT: Community Development Block Grant Funding for Saint
John's Shelter for Facility Renovations

SUMMARY

This report authorizes the Executive Director of the Sacramento Housing and Redevelopment Agency (SHRA) to provide a \$12,000 grant to Saint John's Shelter for women and children and amend the 1991 Community Development Block Grant Program. The funding will assist St. John's in completing facility renovations to increase the daily shelter capacity by 16 clients.

BACKGROUND

Saint John's Shelter for women and children is a nonprofit agency providing emergency shelter and casework services to women and children. Saint John's has been in operation since 1985. In 1989, the shelter relocated its facility from 17th and L Streets to 301 North C Street within the Loaves and Fishes complex. The shelter serves 24 women and children nightly.

In July 1989, Saint John's Shelter applied to the California Department of Housing and Community Development (HCD) for funding under the Emergency Shelter Program to renovate the existing facility to increase bed capacity. In February 1990, Saint John's received a funding award and began the construction process including architectural design and application for necessary building permits. Acquiring the necessary permits delayed the actual renovation work by six months and in March 1991, construction was initiated. The shelter program has been temporarily relocated to the former Loaves and Fishes dining hall for the construction period. While preparing the building for renovation, the contractor determined the existing structure foundation was inadequate to support the proposed expansion. The cost of making the structure sound is \$22,300. The project architect has reviewed the estimate and proposed work and certifies the contractor's findings and estimates. Saint John's had established a contingency fund totalling \$10,300, leaving a financing gap of \$12,000.
