5. Funding of Airport's New Terminal's Public Art Program

Recommendation: Staff recommends approval of funding for new terminal's public art program.

Recommended funding proposal:

- \$8 million for the New Terminal's Public Art Program.. Broken down as:
 - \$5 million for art
 - \$1 million for administration; with any leftover going to art
 - \$2 million for an endowment; for conservation and exhibition programs, with balances paid at trigger points to fund public art program at the airport in perpetuity.

APP Committee on January 9th, rejected staff recommendation in a vote of 2 ayes and 7 noes and 1 absent. APP Committee approved amended recommendation in a vote of 7 ayes, 2 noes and 1 abstention: 7 million dollars for art at the airport, 1 million for an endowment, and an additional 2% would be charged to future change orders and at the end of construction, 20% of this amount would be allocated to maintenance, gallery, and administration. (Note: one more member was present for the amended recommendation than for the first vote.)
