SUBJECT: Recommendation of Bid Award for LANDSCAPE IMPROVEMENTS  
AT STRAWBERRY MANOR PARK

SUMMARY:

The subject project, as a part of the City's Capital Improvement Program, has been advertised for bids. Bids have been received and the City Engineer hereby recommends bid award.

BACKGROUND:

On September 16, 1980, the City Council approved plans and specifications for the subject project and bids were received and opened by the City Clerk in the Council Chambers on October 7, 1980. Bids received are as follows:

FINANCIAL:

The estimated construction cost is \$26,240.00. Although the low bid of Biundo Landscaping, Inc. is 9.88% above the engineer's estimate, it is believed to be the best bid available. Funds in the amount of \$33,171.00 are available in the Community Services Department's budget from Community Development Block Grant Funds.
