SUBJECT: Water Treatment Plant Expansion Study, Selection of Consultant  
Cost Center No. 1586

### SUMMARY

The Council-appointed selection committee for a consultant to perform water treatment plant expansion studies has evaluated seven proponents. The committee's selection is Brown and Caldwell/Dewante and Stowell. Staff recommends the Budget and Finance Committee approve this selection and that the attached resolution be forwarded to the City Council for adoption.

### BACKGROUND

On May 28, 1985, City Council appointed a selection committee to select a consultant to investigate and prepare a report on alternatives for expansion of the City's two water treatment plants.

The committee first solicited statements of qualifications from consultants of recognized experience in water treatment. Seven consultants responded, and it appeared that all were qualified. Proposals were then requested and received from all seven. The selection committee then held interviews of all seven proponents. The firms, or joint ventures of firms, were:

- 1) Culp, Wesner and Culp/Black and Veatch, Cameron Park, CA
- 2) John Carollo Engineers, Walnut Creek, CA
- 3) James Montgomery, Walnut Creek, CA
- 4) Brown and Caldwell/Dewante and Stowell, Sacramento, CA
- 5) CH2M Hill, Sacramento, CA
- 6) Metcalf and Eddy, Sacramento, CA
- 7) Kennedy/Jenks Engineers, Sacramento, CA

The Committee selected the joint venture of Brown and Caldwell/Dewante and Stowell as the recommended consultant.


### FINANCIAL




