REQUEST FOR REINSTATEMENT AFTER RESIGNATION

James R. Craig, Former Intermediate Typist-Clerk

Mr. Craig requested reinstatement to his former classification of Intermediate Typist-Clerk after having resigned on December 1, 1976. He had worked for the City for sixteen months as a Junior Typist-Clerk and eight months as an Intermediate Typist-Clerk. The Director of Finance and Utility Billing Supervisor recommended approval of the reinstatement request.

Inasmuch as Mr. Craig did not meet the Board policy that an employee must have worked at least five years to qualify for requesting for reinstatement, it was staff recommendation that the request be denied. The Board waived the five year policy.

After discussion, Mr. Yee moved to approve the request of Mr. Craig for reinstatement to his former classification of Intermediate Typist-Clerk. Mr. Street seconded the motion which carried by the following vote.

CIVIL SERVICE BOARD REVIEW OF RULES AND REGULATIONS


