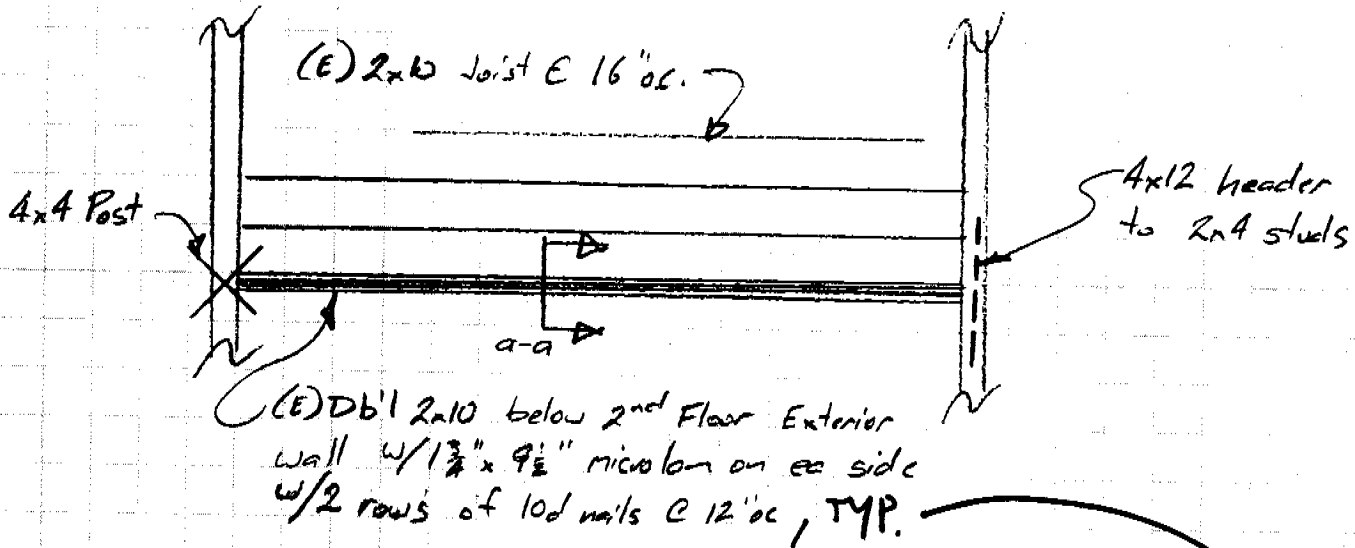

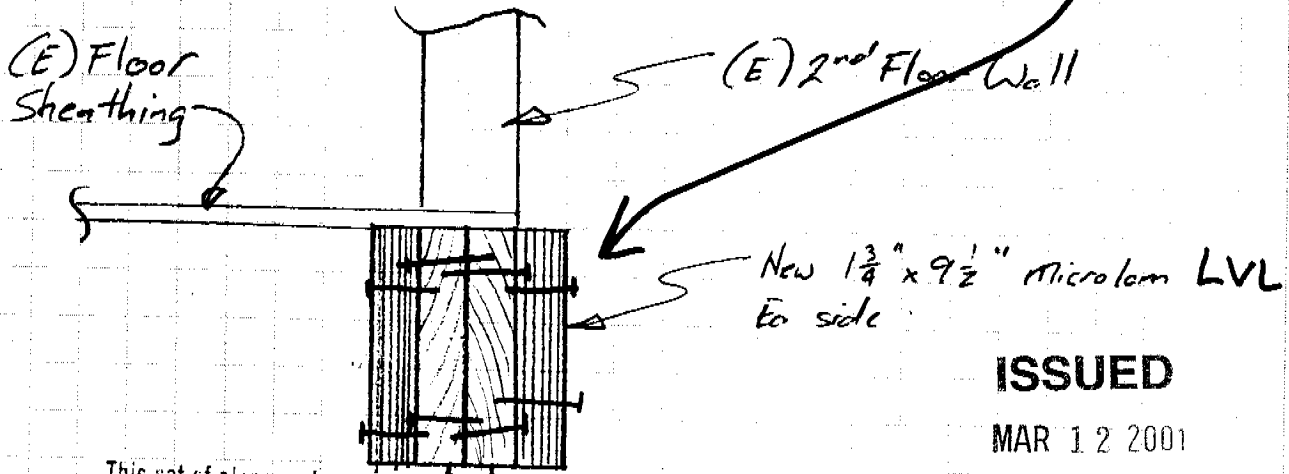

Partial 2nd Floor Framing Plan

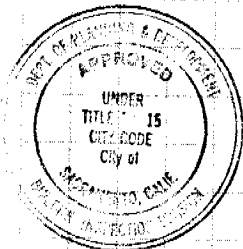
