Description/Analysis

Issue Detail: Assembly Bill 340, the Public Employee Pension Reform Act of 2013 also known as PEPRA, was signed into law on September 12, 2012 and went into effect on January 1, 2013. PEPRA created Government Code Section 7522.56 which requires public agency retirees to wait 180 days after retirement before returning to work for a public agency. This waiting period can be waived should the City Council determine it is critical to fill the specific position. Therefore, this request is before Council for approval at this time.

Fran Lee Halbakken, Assistant City Manager overseeing Public Works, Utilities and the Convention and Cultural Services Departments, is retiring from her position from the City of Sacramento on December 7, 2018. Over the past 32 years, Ms. Halbakken has developed an extensive knowledge of planning, projects, engineering and regulations that govern the City of Sacramento's infrastructure. During her time as Assistant City Manager, Ms. Halbakken has also taken the role of project executive to the Convention Center Complex (C3) project, a \$350 million construction project of key civic anchors: the Sacramento Community Theater, Convention Center and Sacramento Memorial Auditorium. Her knowledge uniquely qualifies her to continue to act as a project executive overseeing this monumental project at a critical time as the project enters the construction phase.

This work is of limited duration, is critical and highly specialized; the City requires an experienced individual to oversee the success of this project. Staff therefore requests Council approve the attached resolution allowing the City to hire Fran Lee Halbakken on a temporary basis to fill this role.

Policy Considerations: The City Council may waive the 180-day waiting period for retired annuitants.

Economic Impacts: None.

Environmental Considerations: Under the California Environmental Quality Act (CEQA) guidelines, continuing administrative activities do not constitute a project and are therefore exempt from review.

Sustainability: Not applicable.

Commission/Committee Action: None.

Rationale for Recommendation: The City Council may waive the 180-day waiting period for retired annuitants when there is a critical need. Expertise in project design and construction

and experience managing the C3 project requires Fran Lee Halbakken's expertise and immediate attention.

Financial Considerations: Funding for the temporary Staff Aide will be provided through the City Manager's Office budget. There is sufficient funding in the City Manager Office FY2018/19 Operating Budget to support the recommendation.

**RESOLUTION AUTHORIZING
THE CITY MANAGER TO HIRE
STAFF AIDE

BACKGROUND

- A. In compliance with Government Code section 7522.56 the City Council must provide CalPERS a resolution when hiring a retiree before 180 days has passed since his or her retirement date.
- B. Fran Lee Halbakken, CalPERS ID 3518823293, is retiring from the City of Sacramento in the position of Assistant City Manager, effective December 7, 2018; and
- C. Section 7522.56 requires that post-retirement employment commence no earlier than 180 days after the retirement date, which is June 5, 2019 without the necessary resolution.
- D. Section 7522.56 provides that this exception to the 180-day wait period shall not apply if the retiree accepts any retirement-related incentive.
- E. The City Council, the City of Sacramento and Fran Lee Halbakken certify that Fran Lee Halbakken has not and will not receive a Golden Handshake or any other retirement-related incentive.
- F. The City Council hereby authorizes City Manager Howard Chan to hire Fran Lee Halbakken as a retired annuitant in a staff aide classification to perform the duties of a Project Executive for the City of Sacramento under Government Code section 21224, effective December 12, 2018.
- G. No matters, issues, terms or conditions related to this employment and appointment have been or will be placed on a consent calendar.
- H. The employment shall be limited to 960 hours per fiscal year.
- I. The compensation paid to retirees cannot be less than the minimum nor exceed the maximum monthly base salary paid to other employees performing comparable duties, divided by 173.333 to equal the hourly rate.

- J. The maximum monthly base salary for this position is \$17,333.00 for which the hourly equivalent is \$100.00. The monthly base salary for this position is \$17,333.00 for which hourly equivalent is \$100.00; and
- K. The hourly rate paid to Fran Lee Halbakken will be \$100.00.
- L. Fran Lee Halbakken has not received, and will not receive, any other benefit, incentive, compensation in lieu of benefit or other form of compensation in addition to this hourly pay rate.

BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1. The appointment of Fran Lee Halbakken as project executive, is necessary to oversee the Convention Center Complex (C3) project at a critical time as the project enters the construction phase.
- Section 2. The City Manager, or the City Manager's designee, is authorized to approve the attached appointment letter with Fran Lee Halbakken.


Dear Fran,
