Dear Dennis,

We received a request from the Tynan Group to release additional pile groups (MPC-15) at Line 9.2 / H.8/H.2 & Line 9.2 / E.8/E.2; (MPC-9) at Lines 9.2/B.8; and (MPC-6) at Lines B.8/4.4. We have reviewed information from Middlebrook + Louie faxed 9/21/99 and agreed to add these groups to the list of released piles from our letter dated 9/17/99.

It should be noted that only the pile driving is being released. There may still be some issues on some of the pile caps that are unresolved.

Our review is based on the requirements of the 1997 UBC. Based on those criteria, the contractor may, at his own risk, proceed with driving piles in the areas indicated above. However, the plancheck for the foundations is not complete and the design team's response to issues raised may cause changes to the work being released. The completion of the remainder of our foundation review will proceed when we receive the completed design from the engineer of record.
