

MINUTES OF CIVIL SERVICE BOARD
CITY OF SACRAMENTO
REGULAR MEETING

March 17, 1938

The Civil Service Board met in regular session in the office of the Board at 7:30 P.M.

Mr. Marshall appeared before the Board explaining that in June, 1936, he had been transferred from the Waste Removal Dept. as Truck Driver to the Park Department as Laborer, at that time being promised by Mr. Evans that his wages would be increased to those of a Truck Driver. However, to date no increase has been received and Mr. Marshall requested the Board to transfer him back to the classification of Truck Driver and to the Waste Removal Dept., or to a Truck Driver position. 


