

Sacramento, California,

March 17, 1930.

The Civil Service Board of the City of Sacramento met in special session on the above date, President Chenu presiding.

PRESENT: Commissioners Maloney, Weisman and Chenu.

ABSENT : None.

The minutes of the special meeting of March 13, 1930, were read and approved as read.

The request of Mrs. Jane Klumpp for a six months' leave of absence contained in a communication directed to Dr. Hall and forwarded to the Civil Service Board for their action, was considered. Commissioner Maloney moved that the request be denied, due to Mrs. Klumpp not having Civil Service standing. This motion was seconded by Commissioner Weisman, and the vote was as follows:

AYES: Commissioners Maloney, Weisman and Chenu.

NOES: None.

Commissioner Maloney moved that Dr. Hall, City Health Officer, be furnished a copy of the eligible list for Stenographer, and that he be advised through the City Manager that the necessary correction in this position must be made in ten days, or no approval could be given to that department's pay roll. This motion was seconded by Commissioner Weisman. The vote was as follows:

AYES: Commissioners Maloney, Weisman and Chenu.

NOES: None.

The Board next discussed that part of Article 20, Section 183, of the Charter wherein is stated "All officers and regular employees of the City after serving one year, shall be entitled to two weeks vacation, annually". Commissioner Maloney moved that an opinion be obtained from the City Attorney as to whether this part of the sec-

tion would apply to those under temporary appointment and not regularly appointed from an eligible list. The motion was seconded by Commissioner Weisman, and the vote was as follows:

AYES: Commissioners Maloney, Weisman, and Chenu.
NOES: None.

Commissioner Maloney moved that Judge Shelley be furnished a copy of the eligible list for Stenographer and that he be advised that the necessary correction and replacement in this position must be made or no approval could be given to that department's pay roll. Commissioner Chenu surrendered the Chair to Commissioner Weisman. Commissioner Chenu thereupon seconded the motion. The vote was as follows:

AYES: Commissioners Maloney and Chenu.
NOES: Commissioner Weisman.

The request of Addison Read, an employee in the Recreation Department, that he be granted a leave of absence from March 1st until October 15, 1930, with a letter from Mr. George Sim, Superintendent of the Recreation Department, was considered. Commissioner Maloney moved that the request be denied, due to Addison Read not having Civil Service standing. The motion was seconded by Commissioner Weisman and the vote was as follows:

AYES: Commissioners Maloney, Weisman and Chenu.
NOES: None.

The secretary was instructed to advise Mr. Sim, through the City Manager, of this action.

The pay roll for the Civil Service Department was next presented for the signature of the President.

The request of Mr. S. J. Aldrich that the Board review Question 20 in his examination paper for Engineer in the Fire Department was considered. The paper was thereupon reviewed. Commissioner Maloney moved that the answer be allowed to stand as corrected. The motion

was seconded by Commissioner Weisman, and the vote was as follows:

AYES: Commissioners Maloney, Weisman and Chenu.
NOES: None.

The request of F. A. Hobson previously discussed by the Board was given consideration. Commissioner Maloney moved that Mr. Hobson's letter be returned to him and he be advised to take his request to the department head. This motion was seconded by Commissioner Weisman, and the vote was as follows:

AYES: Commissioners Maloney, Weisman and Chenu.
NOES: None.

The Board next discussed the classification of Nurse in the Health Department. Commissioner Maloney moved that Dr. Hall, Health Officer, be advised through the Manager and he so advise the nurses that those now employed in the department not in accordance with Civil Service regulations are temporary employees and do not enjoy Civil Service standing. The motion was seconded by Commissioner Weisman. The vote was as follows:

AYES: Commissioners Maloney, Weisman and Chenu.
NOES: None.

The Board next proceeded to review the papers in the recent examination for Desk Sergeant. Upon completion the identity of candidates was established. Commissioner Weisman moved that the Personal Fitness test for Desk Sergeant be held Wednesday, March 19th, at 5:30 o'clock P.M. The motion was seconded by Commissioner Maloney and the vote was as follows:

AYES: Commissioners Maloney, Weisman and Chenu.
NOES: None.

The examination papers for Detective Sergeant were reviewed by the Board, and the candidate's identity established. Commissioner Weisman moved that the Personal Fitness test for Detective Sergeant be held at 5:30 o'clock P. M. Wednesday, March 19, 1930. The motion
