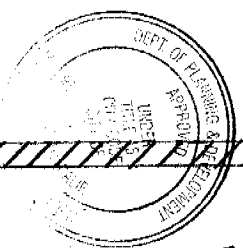

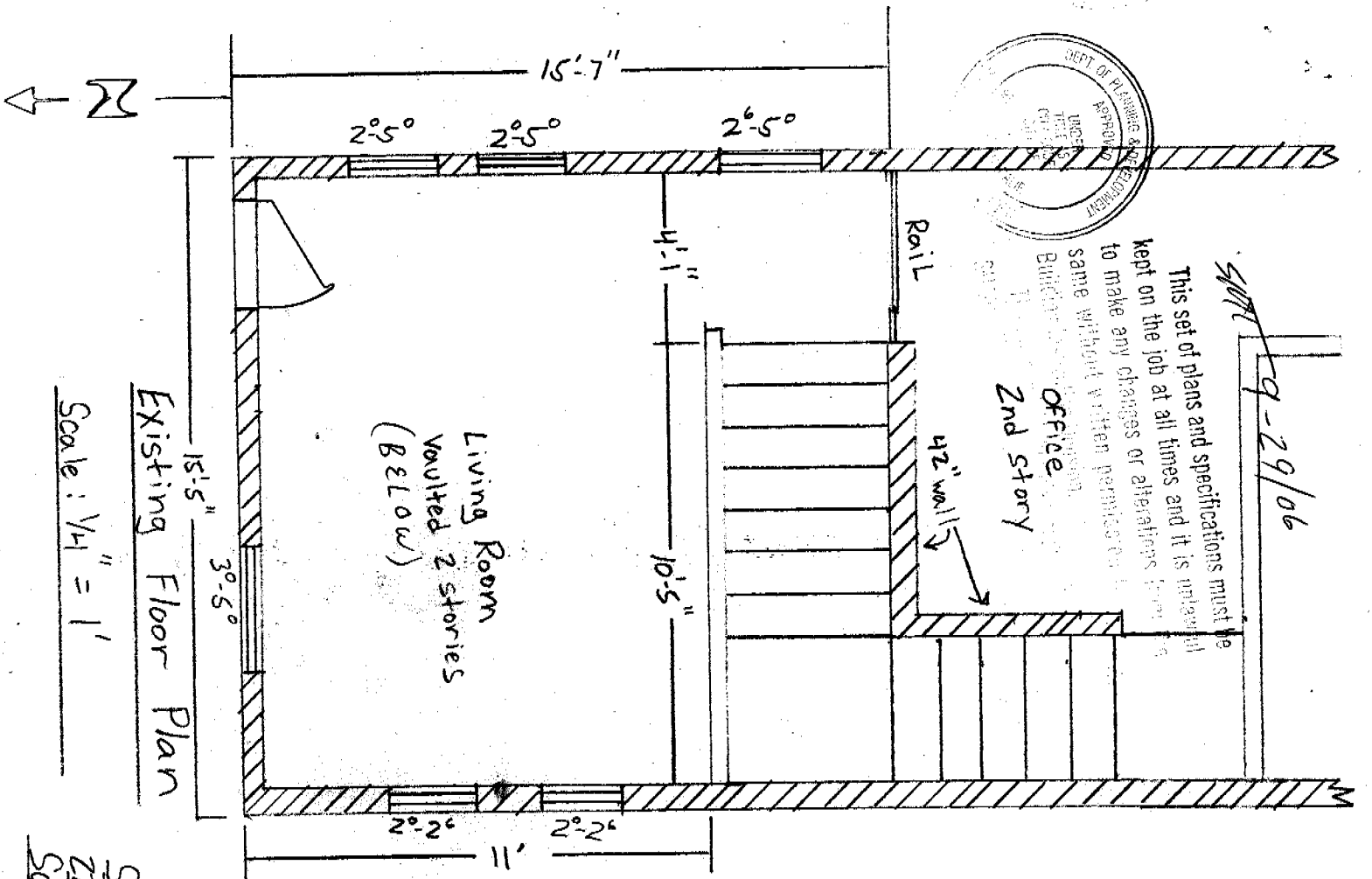

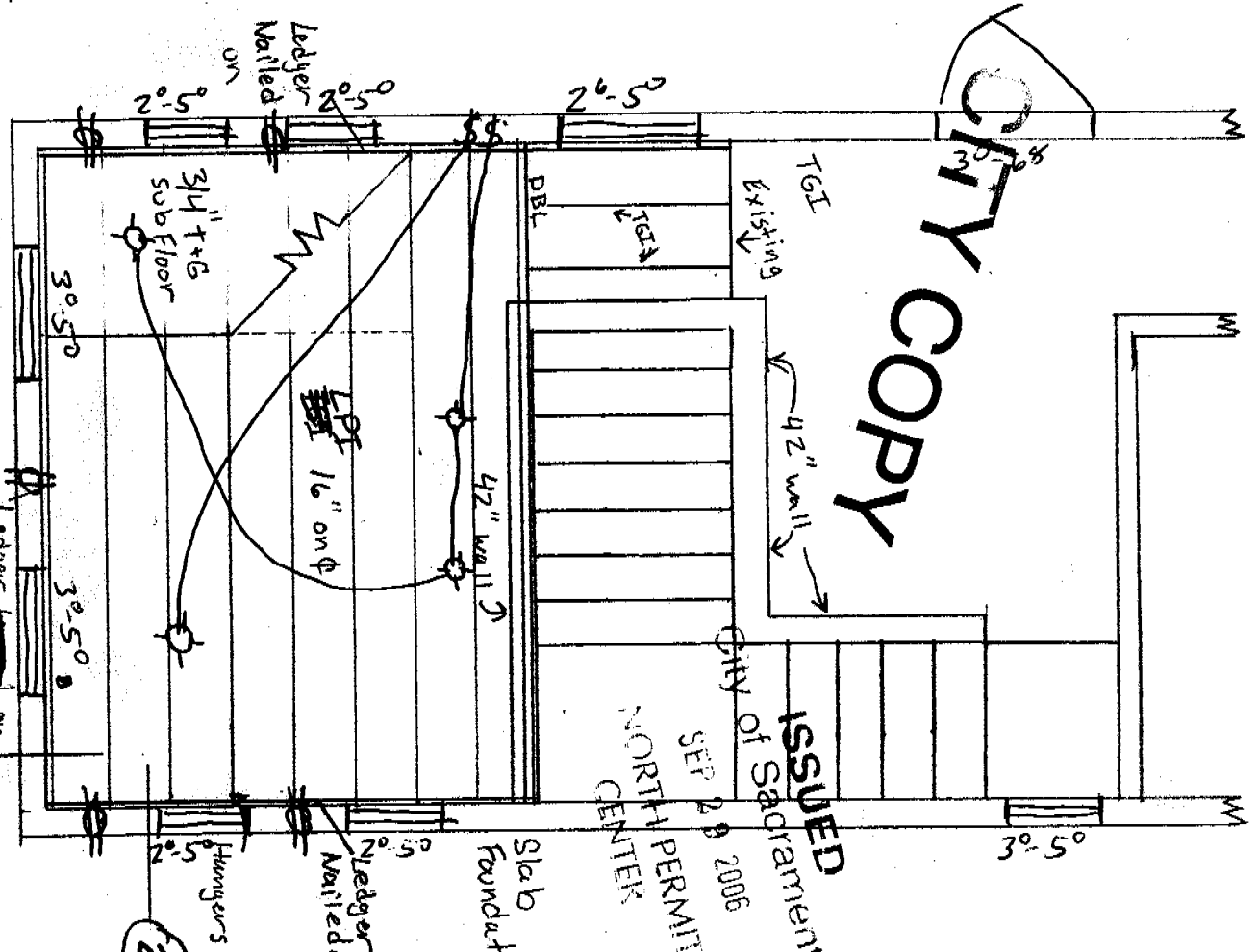

Scale: 1/4" = 1'



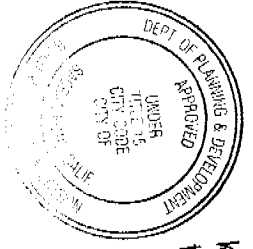
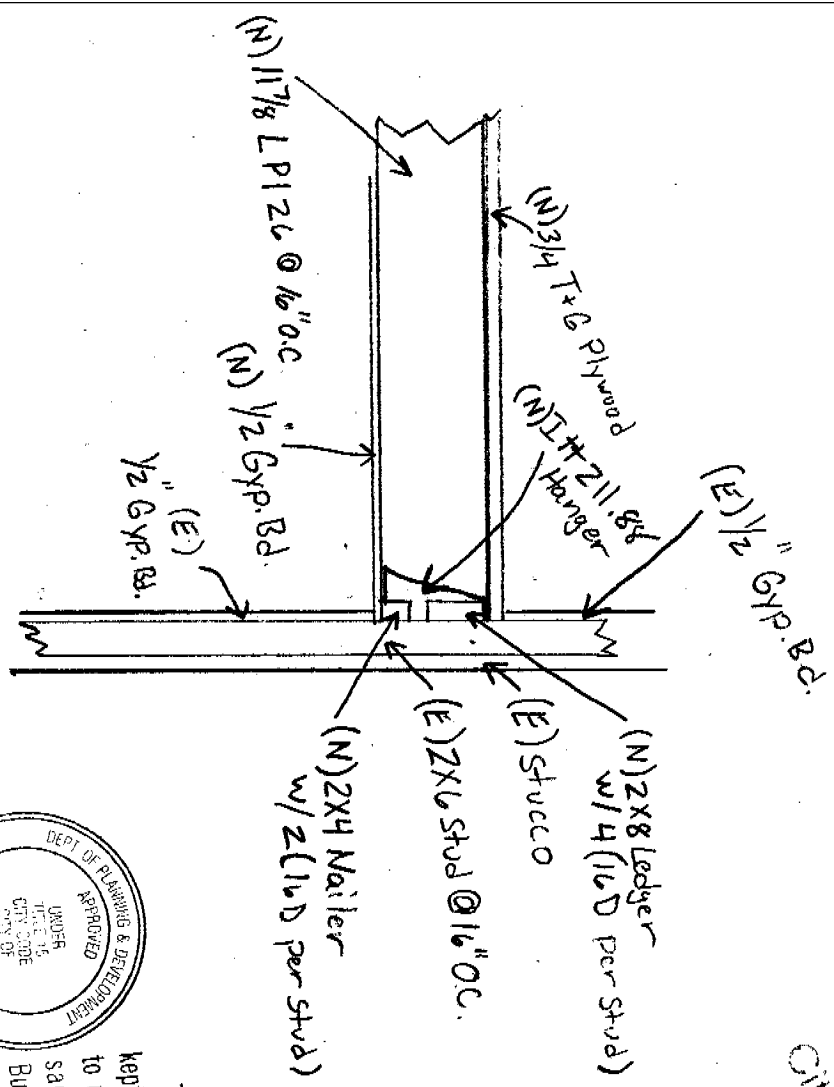
New Second Story Floor Plan

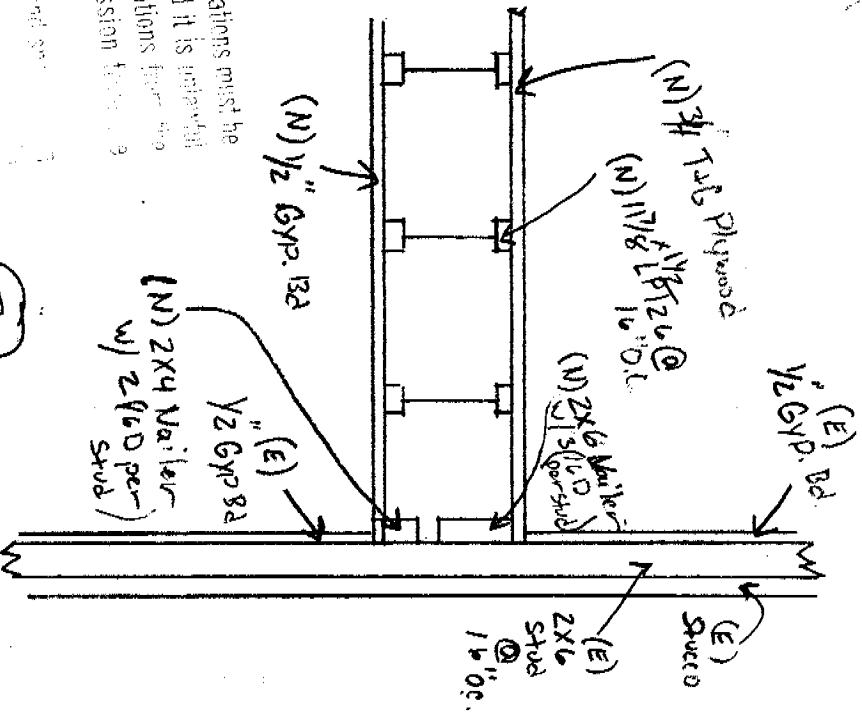
