WHEREAS, Sacramento County has been targeted to receive \$51,259 from the State Department of Economic Opportunity through funds provided by the Stewart B. McKinney Homeless Assistance Act to provide services to the homeless population of Sacramento County; and

WHEREAS, Subtitle "D" of the Stewart B. McKinney Homeless Assistance Act allocates funding for services to the homeless through the Community Services Block Grant program; and

WHEREAS, the Sacramento County Board of Supervisors has designated the Sacramento Employment and Training Agency as the Community Action Agency to administer the Community Services Block Grant program; and

WHEREAS, the State Department of Economic Opportunity has issued a contract to the Sacramento Employment and Training Agency in the amount of \$51,259 for the provision of services under the Stewart B. McKinney Homeless Assistance Act; and

WHEREAS, under the Joint Exercise of Powers Agreement forming the Sacramento Employment and Training Agency, the Sacramento Board of Supervisors and this Council's approval is required in order for the Sacramento Employment and Training Agency to receive new funds;

NOW, THEREFORE, BE IT RESOLVED that the Sacramento City Council accept the award for \$51,259 from the State Department of Economic Opportunity.
