**SUBJECT: RESOLUTION SUSPENDING COMPETITIVE BIDDING AND
AUTHORIZE THE CITY MANAGER TO EXECUTE A CONTRACT
IN THE AMOUNT OF \$120,488.50
WITH TALINI LANDSCAPING FOR NORTH LAGUNA PARK
SAND VOLLEYBALL AND TENNIS COURTS (LL73)**

RECOMMENDATION:

This report recommends that City Council approve by resolution:

- Suspending competitive bidding with a two thirds vote; and
- Authorize the City Manager to execute a contract in the amount of \$120,488.50 with Talini Landscaping for the construction North Laguna Park Sand Volleyball and Tennis Courts.

SUMMARY:

This project was originally awarded to Talini Landscaping in the amount of \$98,272. After the contract was awarded and construction began, it was determined that some of the existing concrete was damaged and needed to be replaced and that the landscaping needed to be expanded to complete the project.

This report recommends that in the best interest of the City, City Council suspend competitive bidding and authorize the City Manager to modify the existing construction contract with Talini Landscaping to include additional walkway improvements and landscaping and increase the contract amount from \$98,272 to \$120,488.50.

BACKGROUND:

The master plan for the North Laguna Park was prepared with the full participation of the community. The community elected to assess themselves to assure that the park was built on a timely schedule and formed the North Laguna Creek Park Community Facility District. The original contract for construction of the park came in under the estimate for the work. After further discussions with the community it was determined that the remaining funds that were allocated for the project should be used to complete other elements of the original master plan.

This report recommends that it in the best interest of the City, City Council suspend competitive bidding and authorize the City Manager to modify the existing construction contract with Talini Landscaping to include additional walkway improvements and landscaping and increase the contract amount from \$98,272 to.

FINANCIAL DATE:

The total current budget for the North Laguna Park Project is \$128,000. The current contract is in the amount of \$98,272 and the extra work amount is \$22,218.50 for a total cost of \$120,488.50. The funding for this project is Quimby but there is a fund balance in the North Laguna Park Community Facility District of \$81,011.82. The community has agreed that the necessary funds to complete this project should come from this fund.

ENVIRONMENTAL CONSIDERATIONS:

This work was addressed as part of the original environmental review for the park.


POLICY CONSIDERATIONS:





**RESOLUTION SUSPENDING COMPETITIVE BIDDING AND AUTHORIZE
