Subject: DaRosa Marina EIR

SUMMARY

The City has received an application for the DaRosa Marina Development. It is recommended that a contract be authorized with QUAD Consultants for \$111,214 to complete the EIR for this proposed project.

BACKGROUND

An initial assessment of the DaRosa project has determined that an Environmental Impact Review is required. Current City policy is to have Environmental Impact Reports prepared by outside consultants.

Requests for Proposals were sent to 149 consulting firms and responses were received from 3 firms. These firms were then interviewed by a selection panel consisting of the Acting Environmental Coordinator, the Project Manager (Planning staff member), a Public Works representative and a representative for the State Land's Commission. The committee recommends QUAD Consultants of Sacramento to perform the EIR.

FINANCIAL INFORMATION

The Consultant cost for QUAD to prepare the EIR is projected to be \$99,979. An additional contingency of \$11,235 is recommended to provide for additional analysis that may be required as the study progresses which would provide a potential total consultant cost of \$111,214.

This cost will be paid from a deposit by the developer. No additional appropriation of city funds is required.

RECOMMENDATION


It is recommended that the Budget and Finance Committee recommend that the City Council adopt the attached resolution providing contract authorization for QUAD Consultants to perform the DaRosa Marina EIR.
