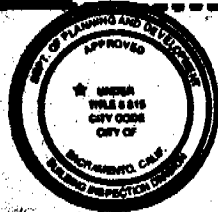
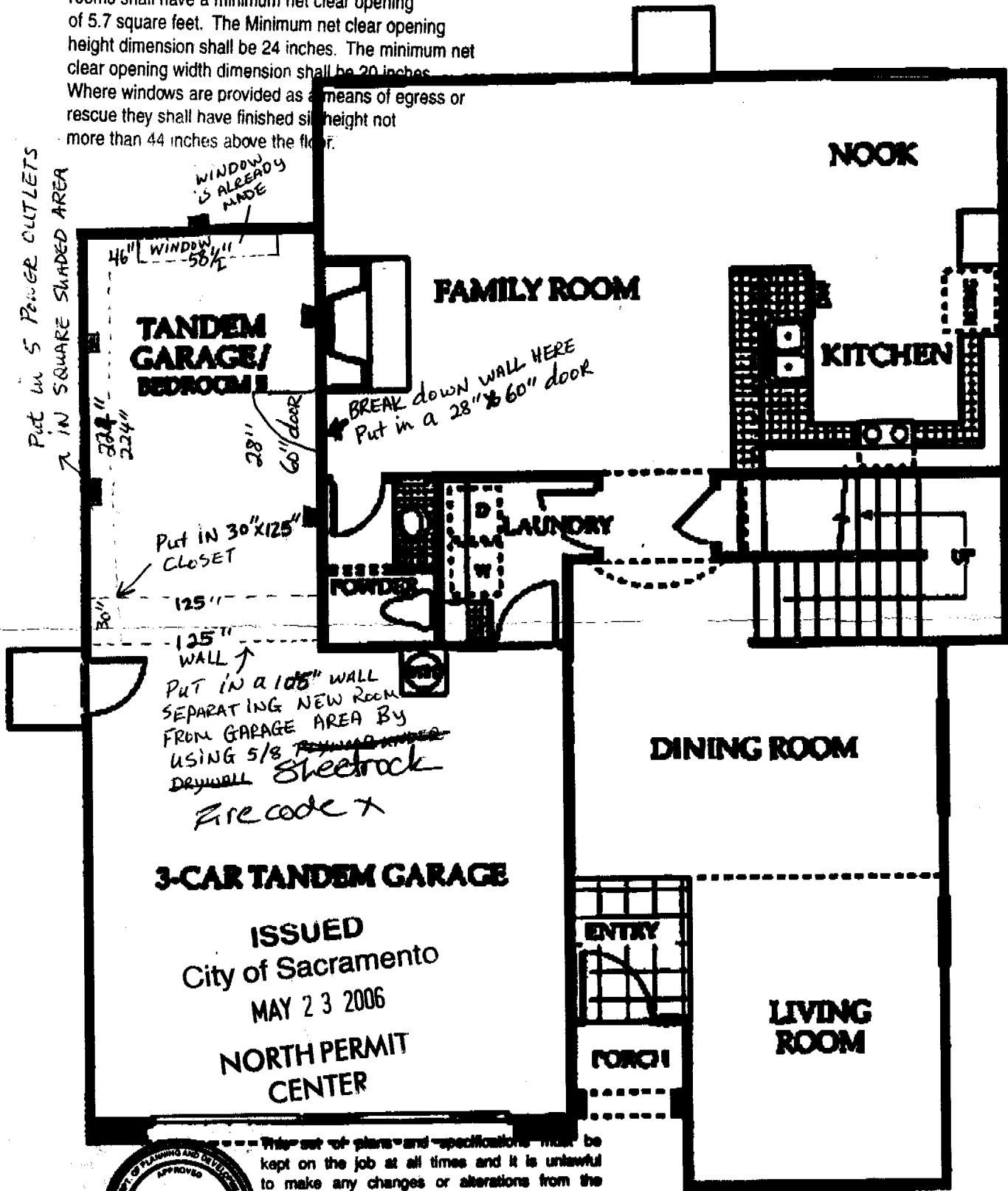

CONDITIONS AND COMMENTS: Preliminary floor plan shows new bedroom will be accessed directly from family room and that a two-car garage will remain. The dimensions of the remaining 2-car garage meet the minimum interior dimensions of 10' wide by 20' deep. The exterior of building will not change for the partial conversion, so design review is not necessary. The footprint of the structure will not change, so no Planning issues with lot coverage. As described here, there are no Planning concerns with this proposal.

Egress or rescue windows from sleeping rooms shall have a minimum net clear opening of 5.7 square feet. The Minimum net clear opening height dimension shall be 24 inches. The minimum net clear opening width dimension shall be 20 inches. Where windows are provided as a means of egress or rescue they shall have finished sill height not more than 44 inches above the floor.
