Communication from Operating Engineers

Local Union No. 3 with reference to increases in prevailing wage scale for

Power Driven Equipment Operators was considered. Mr. F. A. Lawrence, Business Representative, addressed the Board requesting that Operators be placed on a monthly basis of \$334.25 instead of an hourly rate for the particular type of equipment operated.

After general discussion by members of the Board, Mr. Marty moved that the Board recommend to the City Council that the hourly prevailing scale of wages for Power Driven Equipment Operators be established as follows:

Power Shovel Operation	2.10
Tractor Operation	1.95
Roller Operation	1.95
Maintainer Operation	2.10
Fireman and Hot Plant	1.60
Duties not included above	1.25
