

ORDINANCE NO. 1094, FOURTH SERIES

AN ORDINANCE AMENDING SECTION 7 AND SUBDIVISIONS "CRAFTS AND LABOR-SUPERVISORY"; "CRAFTS AND LABOR" AND "ADMINISTRATIVE AND EXECUTIVE" OF SECTION 16 OF ORDINANCE NO. 1066, FOURTH SERIES, PASSED JULY 10, 1945, AND ENTITLED: "AN ORDINANCE FIXING THE SALARIES AND WAGES OF ALL EMPLOYEES OF THE CITY OF SACRAMENTO, AND PROVIDING RULES FOR THE DETERMINATION THEREOF; REPEALING ORDINANCES NOS. 1026, 1031, 1045, 1047, 1052, 1053 AND 1065, RESPECTIVELY, OF THE FOURTH SERIES, AND MAKING THIS ORDINANCE AN EMERGENCY MEASURE TO TAKE EFFECT IMMEDIATELY," AND MAKING THIS ORDINANCE AN EMERGENCY MEASURE TO TAKE EFFECT IMMEDIATELY.

BE IT ENACTED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

SECTION 1: Section 7 of Ordinance No. 1066, Fourth Series, passed July 10, 1945, is hereby amended to read as follows:

" SECTION 7. RE-EMPLOYMENT - EFFECT UPON RATE OF COMPENSATION.

Any employee whose employment with the City of Sacramento was terminated previously by the City and who is re-employed by the City of Sacramento within three (3) years of such termination of employment, shall return to the employ of the City of Sacramento upon the same basis and to the same status which he held at the time that he left. The time absent from the service of the City of Sacramento shall not be considered as service in a classification of employment for the purpose of determining the proper salary step; providing that any person re-employed by the City during the six months period following August 15, 1945, shall also return to the employ of the City of Sacramento upon the same basis and to the same status which he held at the time that he left. The time absent from the service of the City of Sacramento shall not be considered as service in a classification of employment for the purpose of determining the proper salary step.

SECTION 2: Section 16 of Ordinance No. 1066, Fourth Series, passed July 10, 1945, is hereby amended by amending the following Subdivisions to read as follows:

1 Foreman, Carpenter 271.92 Mo.

CRAFTS AND LABOR

1 Carpenter 251.00 Mo.


ADMINISTRATIVE AND EXECUTIVE

2 Superintendent, Water Division 475.00 Mo.


