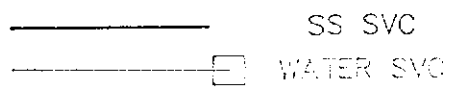
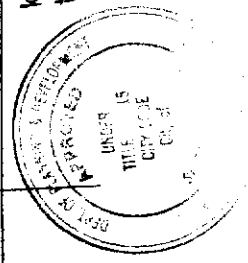


STREAM VIEW WAY
