STAFF RECOMMENDATION

It is recommended that, in the best interest of the City, the City Council adopt the specifications used in the bidding process and accept the lowest responsible bid submitted for the contract resulting from Bid No. 1633 for Miscellaneous Hardware Items for Central Stores. Award is being recommended to Marshall Newell Supply Company, 1795 Tribute Road, Sacramento, CA 95815, in the amount of \$120,000.00.

SUMMARY

Attached is a tabulation of sealed proposals received by the City Clerk for furnishing material in accordance with the specifications used in the bidding process, and recommendation of bid award for Bid No. 1633 for Miscellaneous Hardware Items for Central Stores.

BACKGROUND

This contract is for miscellaneous hardware items, consisting of two hundred forty-seven (247) line items, being purchased for Central Stores for ultimate resale to various City organizations. A few of the items included in this yearly contract are chain, drill bits, hinges, files, flashlights, locks, sandpaper, tapes, extension cords, lubricants and sealants.

Specifications for Bid No. 1633 were publicly advertised and mailed by the City Clerk. Initial advertising and mailing to vendors, bid advertising firms and minority outreach agencies began on May 4, 1994. Sealed bids were publicly opened by the City Clerk on May 25, 1994.

The following is a summary of the recommendation for contract award:

FINANCIAL CONSIDERATIONS

These purchases are initially charged to Central Stores' general inventory account 101-900-9200-4400. When the material is "sold" or issued to a City organization, the actual cost, including sales tax, is charged or debited to that unit's appropriate operating budget line identified on the "Request for Central Stores Supplies" (form P-4).

POLICY CONSIDERATIONS

This recommendation is consistent with the requirements for competitive bidding as detailed in Title 57 of the Sacramento City Code.

MBE/WBE EFFORTS

Requests for bid (RFB) were sent to twelve contractors, six of which were identified as M/WBE firms. The names of the prospective bidders were obtained from the City bid list and by researching the EBMUD Minority and Women Business Enterprise 1992-93 Directory and the State of California - Winter 1994 Disadvantaged Business (DB) and Women Business


Enterprise (WBE) List. In addition, the RFB was sent to several bid advertising agencies, including the Minority Business Exchange and the Sacramento Business Development Center. This bid included provisions for a five percent (5%) bid evaluation preference for City-certified, preference-eligible M/WBE firms. Of the three (3) bids received, one was from a WBE firm, but the bid was incomplete and therefore non-responsive. The vendor recommended for award is not an M/WBE firm.
