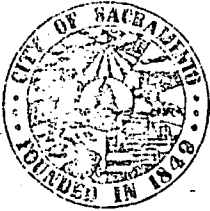

This item is presented at this time for approval of publication of title pursuant to City Charter, Section 38.


BACKGROUND
