SUBJECT: Term of Appointment for Lesley Luevano  
Sacramento Housing & Redevelopment Commission

We have been informed by Commissioner Lesley Luevano that she will be moving from her home at 1725 K Street into a non-Housing Authority unit as of June 1, 1984. Ms. Luevano is a tenant appointment to the Commission, therefore, her move affects her appointment.

On March 29, 1983, the Governing Boards approved restructuring of the Commission and increased the number of members from nine to thirteen. Four members of the former County Community Development and Revenue Sharing Advisory Commission were appointed at that time. In accordance with that action, the terms of all thirteen members expire on August 1, 1984, and a new eleven member Commission should be then appointed (existing members would be eligible candidates). The Board of Supervisors will appoint five members (one by each Board member) and the City Council six members (including the two tenant representatives required by State law, one of whom must be elderly). The six city appointees will need to draw lots in order to achieve a staggered termination schedule. The Board appointments are to expire with the term of the individual Board member selecting that Commissioner.

Commissioner Luevano's departure from the Commission on June 1, 1984, would only be two months from the expiration date of all the current appointments to the Commission. The staff recommends that Commissioner Luevano remain on the Commission until August 1, 1984 in accordance with the Governing Boards previous action. With your permission, we will assume that this is your wish.

Meanwhile, the Board and Council should be preparing for the August 1 reappointment date. With respect to potential tenant representatives, we will be notifying our tenants of the vacancies.
