Applicant must revised plans to show accurate scale (preferably 1/8 scale) or provide proof that lot size is different from parcel maps. UPDATE: Addition meets the setback requirements for the R-1 zone. Lot coverage is under 27%. No issues with the EA 2 zone and the single family home addition. Addition is at least 4 feet from the garage. No other planning issues are apparent.
