

As bidders will need additional preparation time, the bid due date for Bid No. 1582 has been extended one (1) additional week. The revised due date shall be September 30, 1992.


RECOMMENDATION

ADDENDUM NO. 1 TO BID NO. 1582 FOR SHALLOW RIVER  
PATROL VESSEL FOR POLICE DEPT.

1. The bid due date has been changed to **September 30, 1992.**
2. The following information is provided for clarification to the specifications:

2.1 Section 4.0 and 4.7A

For clarification purposes, the vessel shall be capable of being operated at low speeds for extended periods of time without sustaining wear, damage, clogging of the jet propulsion unit or overheating of the engine. Shallow water shall be water with a depth of approximately 12 to 18 inches.

2.2 Section 4.4B


If no modifications to the control lever are necessary then a Teleflex single-lever control #7691250 or equivalent, if authorized by Kodiak, is preferred. However, other control systems will be considered if authorized by Kodiak. Vendor is to indicate below the Manufacturer, Model No. and whether the control has a single or dual lever:

2.3 Section 4.6A

For clarification purposes, a High Performance Marine Base Engine 454 Chevrolet, 460 Ford, or equivalent, shall be considered to be a manufacturers standard offering in a power output to propel a fully loaded vessel a minimum of 40 miles per hour. The engine shall be designed and constructed for long life and durability, not necessarily one modified for a higher power output.

3. All other terms, conditions and specifications of the bid remain unchanged.
4. If a bid package is not being submitted, it is not necessary to return this addendum or acknowledge receipt of such.
5. Bidders submitting a bid package must acknowledge receipt of this addendum prior to the hour and date specified in the bid request by one of the following methods:
  - (a) By signing and returning one (1) copy of this addendum with the bid package if not previously submitted; or
  - (b) If the bid package has been previously submitted, the addendum may be submitted by separate letter, which must include on the outside of the mailing envelope the bid and addendum number and the bid due date. This information must be clearly marked in CAPITAL LETTERS on the outside of the envelope. Failure of your acknowledgement to be received at the City Clerk's Office, 915 I Street, Room 304, Sacramento, California prior to the hour and date specified, may result in rejection of your offer.
  - (c) If, by virtue of this addendum you decide to change an offer already submitted, such change may be made by letter, as specified in (b) above.
