CHANGE ORDER NO. 1 IN THE AMOUNT OF \$18.886.22

 Approve Change Order No. 1 in the amount of \$18,886.22 with Sierra National Construction.

# SUMMARY:

The construction contract for the Orlando Way Street Improvements was awarded to Sierra National Construction on June 30, 1998 in the amount of \$159,170 and was completed on October 15, 1998. Change Order No. 1 will compensate the contractor for placing a 4" asphaltic overlay instead of a 2" asphaltic overlay and accommodating other minor field conflicts.

## **BACKGROUND INFORMATION:**

- The street was scheduled for a 2" asphaltic overlay after placing the new 30" storm drain pipe, 6" water main and water services. The excavation for the proposed pipes caused the existing asphalt to fail. This required the removal of the existing asphalt concrete and placing new 4" asphalt concrete.
- Approval of Change Order No. 1 in the amount of \$18,886.22 will compensate the contractor for this additional work.

## FINANCIAL CONSIDERATIONS:

• The unobligated fund balance for this project, as of October 27, 1998, is \$292,896, which is sufficient to fund Change Order No. 1.

# **ENVIRONMENTAL CONSIDERATIONS:**

A Notice of Exemption was filed for this project on July 7, 1998.

#### **POLICY CONSIDERATIONS:**

The action requested herein is consistent with Sacramento City Code, Title 58.

# MBE/WBE EFFORTS:

The lowest responsible bidder, Sierra National Construction, participation goals were 16.59% MBE and 10.22% WBE.
