On January 5, 2006 the Mayor and City Council adopted Resolution 2006-003 in the best interest of the City, suspending competitive bidding and authorizing the Procurement Services Manager to issue the necessary purchase order to Econolite Control Products, Inc. in the amount of \$137,370. The dollar amount quoted did not include the cost of sales tax. The amended resolution attached reflects the addition of the sales tax.





BACKGROUND
