#### SUMMARY

The attached resolution authorizes the Executive Director to amend the Agency budget to incorporate projected revenues and expenditures for Annual Contributions Contract (ACC) Number CA30-V005-012.

#### BACKGROUND

On February 20, 1989, the Agency submitted an application to the U. S. Department of Housing and Urban Development (HUD) for 50 Section 8 Housing Vouchers.

On March 20, 1989, the Agency received notification that the application was approved for thirty (30) Vouchers. The authorized unit distribution was for ten (10) three-bedroom, ten (10) fourbedroom, and ten (10) five-bedroom Vouchers.

On July 19, 1989, the new Voucher ACC for Project Number CA30-V005-012 was executed.

Approval of the attached resolution will authorize the Executive Director to complete the required actions to add this new allocation of housing assistance to our Section 8 inventory, and to amend the Agency Budget accordingly.
