SUBJECT: Improvement Proceeding No. 5068, Morrison Creek Storm
Sewer, Sanitary Sewer and Water Main Assessment District
(Florin-Perkins Road and Elder Creek Road)

BACKGROUND INFORMATION

Attached is a petition signed by property owners in a district to be assessed for the construction of storm drainage and sanitary sewer systems, channel improvements, water main and bridges, together with all necessary appurtenances, in Morrison Creek Storm Sewer, Sanitary Sewer and Water Main Assessment District.

The petition provides for a Waiver of the Special Assessment Investigation, Limitation and Majority Protest Act of 1931, but does not contain sufficient signatures, therefore, we must proceed under this Act.

RECOMMENDATION

Ordering of the Proceedings is recommended. It is further recommended that the area described in the attached petition and subsequent Resolutions and proceedings shall be referred to hereafter as Morrison Creek Storm Sewer, Sanitary Sewer and Water Main Assessment District.
