**STAFF RECOMMENDATION**

It is recommended that, in the best interest of the City, the City Council adopt the specifications used in the bidding process and accept the lowest responsible bids submitted for the contracts resulting from Bid No. 1663 for Groceries. Award is being recommended to Hangtown Meats Inc., 6414 Capitol Ave., Diamond Springs, CA 95619, in a total amount not to exceed \$20,000.00 and Allied Sysco, 5900 Stewart Ave., Fremont, CA 94538, in a total amount not to exceed \$90,000.00.

**BACKGROUND**

This contract will be used by Camp Sacramento and the 4th R Latchkey Program. It is for groceries and miscellaneous supplies as may be required by these organizations during the contract period.

Specifications for Bid No. 1663 were publicly advertised and mailed by the City Clerk. Initial advertising and mailing to vendors, bid advertising firms and minority outreach agencies began on March 15, 1995. Sealed bids were publicly opened by the Clerk on April 5, 1995.

The following is a summary of the recommendation for contract award:

**FINANCIAL CONSIDERATIONS**

Funds for this purchase are available in various budget lines for both the 4th R Latchkey Program and Camp Sacramento.

**ENVIRONMENTAL CONSIDERATIONS**

Ongoing administrative and maintenance activities, such as purchases of supplies, equipment or materials which are not made for purposes of a public works construction project, do not constitute a "project" and are exempt from the California Environmental Quality Act (CEQA). CEQA Guidelines, Sections 15061(b)(1), 15378(b)(3).

**POLICY CONSIDERATIONS**


This recommendation is consistent with the requirements for competitive bidding as detailed in Title 57 of the Sacramento City Code.

**MBE/WBE EFFORTS**

Requests for bid (RFB) were sent to 13 vendors, 7 of which are M/WBE firms. The names of the M/WBE firms were obtained from the City bid list and by researching the East Bay Municipal Utility District (EBMUD) Minority and Women Business Enterprise 1992-93 Directory, the City of Oakland MBE/WBE Directory and the State of California, Summer 1994 Disadvantaged Business (DB) and Women Business Enterprise (WBE) List. In addition, the RFB was sent to several bid advertising agencies, including the Small Business Exchange and the Sacramento Minority Business Development Center (NEDA).


This bid included provisions for a five percent (5%) bid evaluation preference, not to exceed \$25,000.00 total, for City-certified, preference-eligible M/WBE firms. Of the four bids received, none was from a Minority/Woman-Owned Business Enterprise.
