**SUBJECT:** APPROVAL OF PLANS AND SPECIFICATIONS, ACCEPTANCE OF BID AND CONTRACT AWARD FOR THE FLORIN PERKINS ROAD AND BELVEDERE AVENUE TRAFFIC SIGNAL PROJECT (PN: SJ06)

**LOCATION AND COUNCIL DISTRICT:**

Florin Perkins Road and Belvedere Avenue - Council District 6.

**RECOMMENDATION:**

This report recommends that the City Council:

- Approve the plans and specifications;
- Accept the bid of M&M Electric in the amount of \$92,777; and
- Authorize the City Manager to execute a contract for the Florin Perkins Road and Belvedere Avenue Traffic Signal project.

**FOR COUNCIL MEETING OF:** April 9, 1996

**SUMMARY:**

This project will install a new traffic signal at the intersection of Florin Perkins Road and Belvedere Avenue. Interconnect cable will also be installed, in existing conduit, from Jackson Road to Elder Creek Road for traffic signal coordination. In addition, this project will include pedestrian facilities. New handicap ramps will be constructed at this location.

**BACKGROUND INFORMATION:**

- This project was authorized in the 1993/94 Capital Improvement Program.
- This project was advertised and bids were received on March 13, 1996 and are summarized below:

- The construction estimate is \$137,000.
- All bidders met MBE/WBE goals.
- Approval of the plans and specifications and award to M&M Electric is recommended.

**FINANCIAL CONSIDERATIONS:**

- The project budget for Florin Perkins Road and Belvedere Avenue is \$170,000.
- The unobligated fund balance as of March 13, 1996 was \$137,099 which is sufficient for award.

**ENVIRONMENTAL CONSIDERATIONS:**

The Planning Services Division, Environmental Section, has determined that this project is exempt from CEQA per State Class 1 and 2 and Section Number 15301(c) and 15303(c).

A notice of categorical exemption was filed for this project on December 29, 1995.

**POLICY CONSIDERATIONS:**

The action requested herein is consistent with Sacramento City Code, Title 58.


**MBE/WBE EFFORTS:**


