STAFF ACTION AND CONDITIONS OF APPROVAL:

Staff has reviewed the proposed project, and approves it with the following conditions of approval:

1. Repair and replace wood lap siding to match existing in size, shape, texture, and dimension.
2. All windows shall be replaced with dual pane vinyl framed windows in existing openings.
3. All windows at front elevation shall be single hung, vinyl framed windows to replace existing.
4. Retain original trim and sills.
5. Any woodwork shall be smooth finish. No rough sawn.
6. Paint entire house, all gutters, exposed wood and trim shall be painted a complementary accent color.
7. Provide new roofing, minimum 30 year laminated dimensional composition shingle.
8. The scope of exterior work is limited to the above listed items. Any changes are subject to Design Review staff approval.
