

RESOLUTION No. 790

Adopted by The Sacramento City Council on date of

BE IT RESOLVED, FOUND, AND DETERMINED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

That the public interest and necessity require the acquisition by said City of Sacramento of certain real property herein described as and for a right of way for airport runways for the landing and taking off of aircraft;

BE IT FURTHER RESOLVED, FOUND, AND DETERMINED that the said property hereinafter described is necessary for such purposes;

BE IT FURTHER RESOLVED, FOUND, AND DETERMINED that the City Attorney be, and he is hereby, authorized and directed to commence proceedings in eminent domain to acquire said property for said purpose.

The property herein found necessary to be taken is described as all that real property in the County of Sacramento, State of California, described as:-

Parcel 1 of Davis property as shown by Book 3 of Surveys, Survey No. 77, being a portion of property formerly owned by L. R. Davis situate in Section 25 Township 8 North, Range 4 East, formerly partitioned to Nellie P. Walker, described as follows:-

Beginning at a point in a fence marking the line dividing Section 25, Township 8 North, Range 4 East into North and South halves from which point of beginning an iron pin marking the quarter corner common to said Section 25 and Section 30, Township 8 North, Range 5 East, bears South 89° 56' 53" East 2134.94 feet; thence from said point of beginning South 0° 05' West 20.0 feet to an iron pipe monument; thence continuing South 0° 5' West 1298.48 feet to an iron pipe monument set in fence line; thence North 89° 51' 27" West 503.35 feet along said fence line to an iron pipe monument set in fence corner; thence North 0° 05' East 1297.69 feet along fence line to an iron pipe monument; thence continuing North 0° 05' East 20.0 feet to a fence corner; thence South 89° 56' 53" East along fence line, a distance of 503.35 feet to the point of beginning, containing 15.23 acres more or less, the net area of said tract (less the northerly 20.0 feet thereof which is hereinafter reserved for private road purposes) being 15.00 acres more or less, and

That portion of the property formerly owned by L. R. Davis, situate in Section 25 Township 8 North, Range 4 East, partitioned to Newton B. Davis described as follows:-

Beginning at a point in fence marking the line dividing Section 25, Township 8 North, Range 4 East into North and South halves from which point of beginning an iron pin marking the quarter corner common to said Section 25 and Section 30 Township 8 North, Range 5 East, bears South 89° 56' 53" East 1631.90 feet along said fence line; thence from said point of beginning South 0° 05' West 20.0 feet to an iron pipe monument; thence continuing South 0° 05' West 388.43 feet to an iron pipe monument; thence continuing South 0° 05' West 388.29 feet to an iron pipe monument; thence continuing South 0° 05' West 388.15 feet to an iron pipe monument; thence continuing South 0° 05' West 134.40 feet making a total distance from point of beginning of 1319.27 feet to an iron pipe monument set in fence line; thence North 89° 51' 27" West 503.04 feet along said fence line to an iron pipe monument; thence North 0° 05' East 1298.48 feet to an iron pipe monument; thence continuing North 0° 05' East 20.0 feet to a point on fence line first hereinabove referred to; thence South 89° 56' 53" East 503.04 feet to the point of beginning containing 15.23 acres more or less, the net area of said tract (less the northerly 20.0 feet thereof, which is here-
