The Civil Service Board met in special session in the office of Board at 8:00 P.M., President Chenu, presiding.

CLASSIFICATION  
CLUNIE MEMORIAL CUSTODIAN

After discussing a request from the Superintendent of Recreation for a Custodian at the Clunie Memorial, and reviewing the duties and minimum requirements of the position, Commissioner Stacy moved that the classification of Custodian - Clunie Memorial be established with a salary range of \$125 to \$175 per month plus living quarters. Seconded by Commissioner Deise and un-animously carried.


