Dick Snyder, Retirement System Manager, was present to answer any questions. He explained that the current Code requires that all retirement hearings be tape recorded. By allowing the use of a shorthand reporter at the hearings, various facilities may be used for such hearings, which will expedite the backlog of cases. He also pointed out that a shorthand reporter is always in attendance at these hearings.

Councilman Bradley moved to approve the amendment to City Code Section 34.1407. Councilman Pope seconded the motion, and it was unanimously approved.


MINUTES:

David Martinez, Deputy City Manager, was present to discuss this bill. He stated that the City has some real problems with this bill, as it is difficult enough for us to get annexation without having it "substantially developed" first, as this bill recommends. He also stated that the League of California Cities is strongly against this bill.


Councilman Kastanis asked if there has been any contact with the State LAFCO. He stated that he is a representative of the State LAFCO. He feels they will oppose this bill, but he doesn't know for sure.

Councilman Pope moved to oppose AB 169. Councilman Kastanis seconded the motion, and it was unanimously approved.
