

ORDINANCE NO. 1010, FOURTH SERIES.

AN ORDINANCE AMENDING SECTION 4 OF ORDINANCE NO. 239, FOURTH SERIES, PASSED SEPTEMBER 3, 1925, AND ENTITLED: "AN ORDINANCE RELATING TO THE USE OF SIDEWALKS IN THE CITY OF SACRAMENTO; DEFINING THE TERM 'SIDEWALK' AS USED IN THIS ORDINANCE; PROHIBITING PROJECTIONS OVER SIDEWALKS, OR THE ERECTION OR MAINTENANCE OF ANY OBSTRUCTIONS THEREON; PROVIDING A PENALTY FOR A VIOLATION OF THE PROVISIONS OF THIS ORDINANCE, AND REPEALING ORDINANCE NO. 297, THIRD SERIES, PASSED AUGUST 16TH, 1917."

BE IT ENACTED BY THE COUNCIL OF THE CITY OF  
SACRAMENTO:

SECTION 1: Section 4 of Ordinance No. 239, Fourth Series, passed September 3, 1925, is hereby amended to read as follows:

Section 4. Any sign, post, structure or obstruction of any kind erected or maintained on any of the sidewalks in the City of Sacramento, is hereby declared to be a nuisance and shall be removed by the Superintendent of Streets immediately upon their existence being ascertained; provided that the City Engineer may, on proper written application, grant a revocable permit for the erection and maintenance of certain benches for the use of the public, to be placed on public sidewalks at such places as the City Engineer shall designate within the City of Sacramento, in such a manner as not to interfere in any way with the use of the sidewalk by pedestrians.

Such benches shall be erected and maintained in such a manner as to conform with the specifications required by the City Engineer, and the construction and erection thereof shall be under the supervision of said City Engineer.

The granting of the permit to maintain such benches shall be conditioned on the execution by the permittee of a contract to save the City harmless from any liability which might arise by reason of the erection and maintenance of such benches.

Provided, further, that the City Council may, on proper written application, grant a temporary permit for the erection of temporary structures or signs for the use or information of the public at times when public celebrations are being held, when such structures or signs shall not in any way interfere with the use of the sidewalk by pedestrians, and which shall be immediately removed when the necessity for their maintenance has ceased.
